What Is It?

Phyto UltraComfort* is a combination of ingredients designed to reduce minor occasional pain by supporting healthy enzyme and immune mediator activities.*

Uses For Phyto UltraComfort*

Reduces Minor Pain: Willow bark has a long history of traditional use for reducing minor pain. Several randomized human trials illustrate its ability to do so primarily through the actions of salicin, a source of salicylic acid. Studies reveal that *Boswellia serrata* also has the potential to provide statistically significant support for reducing mild pain. A review of 12 human studies indicates that devil's claw may reduce mild pain to promote musculoskeletal comfort and function. dl-Phenylalanine supports enkephalin activity, which impacts pain receptive neurons.*

Maintains Healthy Cytokine Response: Devil's claw promotes both healthy cyclooxygenase-2 and 5-lipoxygenase enzyme activity. The boswellic acid 3-acetyl-11-keto-beta-boswellic acid (AKBA) may be particularly supportive in maintaining healthy 5-lipoxygenase enzyme activity and leukotriene metabolism to maintain tissue comfort. Curcumin maintains healthy cyclooxygenase-2 enzyme activity while supporting healthy prostaglandin, leukotriene and thromboxane metabolism. Its ability to maintain a healthy cytokine response has also been attributed to regulation of nitric oxide release. Additionally, willow bark helps to maintain healthy prostaglandin metabolism and blood flow.*

What Is The Source?

Willow bark extract is derived from *Salix alba* and standardized to contain 15% salicin. *Boswellia serrata* extract is derived from the gum resin. One extract is standardized to contain 70% boswellic acids and the other is standardized to contain 30% 3-acetyl-11-keto-beta-boswellic acid (AKBA). Turmeric extract is derived from *Curcuma longa* root and standardized to contain 95% curcuminoids. Devil's claw extract is derived from *Harpagophytum procumbens* and *Harpagophytum zeyhari* root and standardized to contain a minimum of 5% harpagosides. dl-Phenylalanine is synthetically produced. Ascorbyl palmitate is derived from corn dextrose fermentation and palm oil.

Recommendations

Pure Encapsulations® recommends 2 capsules 1-3 times daily, with meals.

Are There Any Potential Side Effects Or Precautions?

Not to be used by pregnant or lactating women. Not to be used by children (ages 18 and under). Individuals with stomach problems or ulcers should consult their physician before using this product. This product contains salicylates. Do not take if allergic to aspirin. Do not combine with aspirin or other products containing salicylates. Rare side effects of ingredients in this formula include gastrointestinal upset, diarrhea, constipation, heartburn, skin rash or headache. Curcumin (turmeric) is not recommended for individuals with bile duct obstruction.

Are There Any Potential Drug Interactions?


Do not take with anticoagulant or antiplatelet drugs. Avoid taking dl-phenylalanine with Levodopa. It may also be contraindicated with neuroleptic and MAOI medications. Consult your physician for more information.
